




#### What's in the FY23 Omnibus for Children?

- Pregnant Worker Fairness Act & PUMP Act Pass
- New permanent Summer Electronic Benefit Transfer (EBT) program with \$40 in grocery benefits per child for each summer month for families that rely on free or reduced price school meals
- Requires 12 months of continuous coverage for kids in Medicaid and CHIP
- Child Care and Development Block Grant, is funded at \$8 billion a nearly \$2B or 30% increase (\$56m increase for PA), \$12 Billion for Head Start

## < 6 Mo. to Avoid A Global Catastrophe!


The U.S. hit the current debt ceiling in January. Since that time, the Treasury Department has been using "extraordinary measures" to avoid default.

House Republicans want spending caps and to cut spending back to FY 2022 levels (\$100 billion+ of cuts - a 30% cut for child care!)

If SS, Medicare, Defense and Vets' health cuts are avoided, the other annually funded programs would be cut an average of **24 percent** to achieve the House Republican goal of cutting back to FY 2022 levels.

#### PROGRESS AROUND THE STATES

- Hawaii introduced <u>H.B 547</u> to subsidize infant and toddler child care worker wages, increasing pay to \$16.00 per hour.
- Kentucky introduced <u>S.B. 32</u> to increase the state minimum wage to \$15.00 per hour for large employers by 2027.
- Tennessee introduced companion bills <u>H.B. 478</u> and <u>S.B. 398</u> to provide a stipend for child care to eligible state employees.
- Michigan lawmakers voted to advance companion bills <u>S.B. 3</u> and <u>H.B. 4002</u> to increase the refundable state earned income tax credit from 6% to 30% of the federal credit.
- Minnesota had two bills establishing a 12-week paid family leave program, <u>H.F. 2</u> and <u>S.F. 2</u>, pass out of their respective committees to be considered on the House and Senate floors.





## EXTRA SNAP PAYMENTS ENDING

#### Extra SNAP is Ending What you need to know

#### WHAT IS CHANGING?

The extra SNAP payment, officially called Emergency Allotments, will end in February 2023.

Starting in March, you will only get your regular SNAP payment loaded to your EBT card in the first half of the month. There will be no second payment later in the month.

#### WHAT SHOULD I DO?

Without the extra SNAP, your benefit amount is based on your income and the expenses the program allows you to report.

You should report up-to-date information as soon as possible so that you are receiving all of the benefits you are eligible for.

#### MAKE SURE THE CAO HAS UP-TO-DATE INFORMATION

Make sure you report important changes, like:

#### 1) Your Address.

- You may miss important updates if the CAO does not have your current address.
- 2) Your income and the income of others in your SNAP household.
- Did you lose work hours or have your pay cut? If you are earning less, you
  may qualify for more SNAP benefits.
- 3) Your expenses and other allowable deductions.
- Are you paying more for child care?
- If you are a senior or have a disability, do you pay more than \$35 in medical expenses per month? Providing proof of these expenses may help you qualify for more SNAP. Learn more at <u>cutt.ly/deductions</u>.
- Did your rent, mortgage, or property taxes increase? In some cases, reporting this may help you qualify for more SNAP.

#### YOU DO NOT NEED TO SPEND ALL OF YOUR SNAP

You can keep SNAP benefits on your EBT card as long as you want, so long as you use the card once every 9 months to keep it active. If you find that the extra SNAP is giving you a little more money for food than you need to spend, you can save it to spend in a later month, to provide a little wiggle room for when the second payments end in March 2023.









- February will be the last month when SNAP recipients receive an "Emergency Allotment" payment in the 2nd half of the month.

## PENNSYLVANIA'S ESSA PRESCHOOL DEVELOPMENT GRANT BIRTH THROUGH FIVE (B - 5)

- The Pennsylvania Department of Education (PDE) has been awarded a Preschool Development Grant Birth through Five (PDG B-5) grant of \$10.5 million for one year. Pennsylvania's new grant is one of 45 recently announced by the US Department of Health and Human Services.

  - Family Child Care Homes (FCCHs) \$50
- Please make sure to carefully check your Provider Payment Summaries each month to confirm the registration fees were applied appropriately.

## ANNOUNCEMENT ELRC 23-01: INCREASE TO CHILD CARE WORKS BASE PAYMENT RATES FOR DHS CERTIFIED PROVIDERS

- The purpose of the Announcement is to announce an increase to base rates paid by PA Department of Human Services (DHS) to certified child care providers participating in Child Care Works (CCW). Base payment rates are also known as the Maximum Child Care Allowance (MCCA).
- Effective March 1, 2023, if the DHS certified child care provider's private pay rates continue to be higher than the newly published MCCA, participating DHS certified child care providers will not have to submit a new Appendix C-1. The new rates will automatically be reflected in the payment for March invoices which occurs in April.
- If a DHS certified child care provider wants to update their private-pay rates, they must communicate those changes to families and provide verification of the updated child care provider's private-pay rates to the Early Learning Resource Center (ELRC). The updated rate will become effective the first of the month following the date the verification was received by the ELRC, if submitted after March 31, 2023.
- Effective March 1, 2023, OCDEL is implementing increases to the MCCA rates. The new MCCA chart is posted online here.
